- Legislative Session Update:
  - Session begins 2<sup>nd</sup> week of January.
  - Draft bill for .35 retail delivery fee to be used for transportation purposes. Would generate an estimated \$25 million in transportation revenue in the initial year.
  - Waiting to see a draft of RUC bill.
  - Federal Exchange Program has been extended in Governor's proposed budget.
  - \$350 million appropriation to the PWAA in the Governor's proposed budget.

### CRAB:

- Data Position Funded.
- \$5 million available for assistance with 105,500lb load rating requirement. Unfortunately the proposal funds it with \$2.5 million from RAP and 2.5 million from CAPP.
- Local access road grant program not funded.
- Expecting several public works procurement bills this session.
- Legislative Update via ZOOM every two weeks with written updates in between.
